About the Goods Vehicle Movement Service (GVMS)

On 31/12/20 the UK Government introduced a new IT platform called the Goods Vehicle Movement Service (GVMS) to support the Pre-Lodgement model for both imports and exports and to facilitate Transit movements.

The pre-lodgement model (developed as an alternative for where border locations may not have the space and infrastructure to operate temporary storage regimes) ensures that all declarations are pre-lodged before they board - this will maintain flow, especially at high volume RoRo locations.

GVMS enables:

- declaration references to be linked together so that the person moving the goods (e.g., a driver) only has to present one single reference (Goods Movement Reference or GMR) at the frontier
- the linking of the movement of the goods to declarations, enabling the automatic arrival/departure of goods within HMRC systems.
- Automation of the Office of Transit function, marking the entry of goods into NI or GB
- notification of the risking outcome of declarations (held or cleared) in HMRC systems to be sent to the person in control of the goods by the time they physically arrive in GB.

GVMS has been live for goods moving under CTC (Common Transit Convention) procedures into GB, since 1 Jan 2021. It will be used for both imports and exports from 1 January 2022 as well as goods moving under TIR (Transports Internationaux Routiers or International Road Transports) procedures.

Who should register

If you're a haulier that moves goods through one or more ports that uses the Goods Vehicle Movement Service, you should apply to use Goods Vehicle Movement Service.

If you're a haulier that moves goods into Great Britain (England, Wales and Scotland) from the EU, you only need to register if your goods are moving under the Common Transit Convention.

When to register

You can register from 8 December 2020.

Before you register

You should use exactly the same address for Goods Vehicle Movement Service registration that you have used for any other Government Gateway service.

Your registration application will be delayed if you use a different address.

You can find out the address you have previously used by accessing a HMRC service you're already registered for and checking your details.

To register, you will need to [get an EORI](#) starting with GB.

You will need a Government Gateway user ID and password. If you do not have a user ID, you can create one for your business when you register.

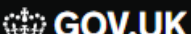

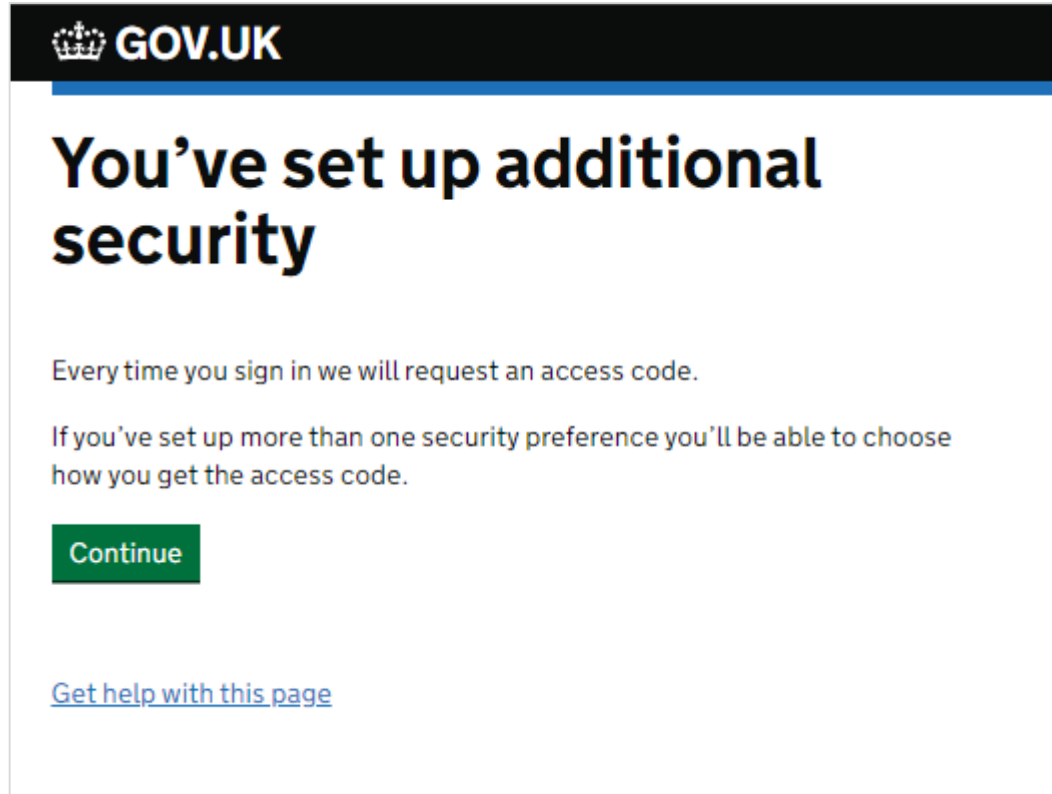

For drivers

The driver will need to present this goods movement reference (GMR) at the port of departure.

Check if an inspection is needed

To find out if an inspection of their goods is needed the driver should use the [‘Check if you need to report for an inspection’ service \(opens in new tab\)](#) before arriving at their port of arrival or departure.

For hauliers

Before the goods travel to the port of departure you will need to:

- give a copy of this GMR to the driver moving these goods – they will need to present this at the port
- give the driver details of the [‘Check if you need to report for an inspection’ service \(opens in new tab\)](#)
- check for and correct any errors showing on the GMR dashboard

You can change any of the details for this GMR at any time before it is checked in. The barcode and reference will stay the same, so you only need to print or share this once.

What happens next

You do not need to report for an inspection of your goods, but you may still need to report for other controls.

Other controls you may need to report for

Some goods movements still need other controls at their point of entry.

These include controls on:

- transit movements arriving in their country of destination (report to an office of destination)
- movements of animals, plants, or organics
- goods covered by the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES)

Check with your declarant.

If you have no other controls to report for

You can continue from your port of arrival, to your destination.

Further information tells you that you might need to report for other controls

Other controls are explained in more detail and could be:

- Certain transit movements
- DEFRA checks
- CITES checks

If you have checked with your declarant and no other controls are needed, you can carry on to your destination.

Step 4.1

The result could be that you **MUST** report for an inspection.

Inspection needed

The goods are not cleared from customs control.

You are advised that the goods have **NOT** cleared customs controls and told what you need to do next.

What happens next

Report to UK Border Force for an inspection of the goods at your nearest customs inspection site. This is either at your port of arrival or inland. [Check GOV.UK for details \(opens in new tab\)](#).

Use this link to get more information about Inland Border Facilities (IBFs), including where you can go and how to book-in in advance.

If you are ending a transit movement

You must also present the goods at your nearest office of destination. This is usually at the same inspection site.

You are told what to do if you're ending a Transit movement.

You may also need to report for additional controls

Some movements need additional controls at their point of entry.

Further information tells you that you might need to report for additional controls

These include movements of:

- food, animals or organics
- goods covered by the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES)

How to correct errors

You need to check the status of your GMR in the GVMS dashboard.

Click the GMR reference to go back and correct errors

You can see clearly if there are any errors

If you do not correct errors in the GMR the driver will be turned away from check-in and will need to move to a designated parking area or away from the port to resolve any issues with the haulier or intermediary who created the GMR.

How to avoid common errors

Incorrect Transit Accompanying Document (TAD) Movement Reference Number (MRN) for Transit movements

Only the TAD MRN from NCTS is entered in the declaration reference box. If you enter an invalid number you will receive an error message

Incorrect Entry Reference Numbers (ERN) or Movement Reference Numbers (MRN) from CHIEF or CDS

if you enter an invalid ERN or MRN you will receive an error message.

Entry in Declarants Records (EIDR)

You can only enter the EORI of a trader who is authorised to use 'Simplified Customs Declaration Procedures'. If the EORI is not authorised you will receive an error message.

Incorrect Vehicle Registration Number (VRN) and / or Trailer Reference Number (TRN)

You must ensure the correct Vehicle Registration Number and Trailer Reference Numbers are entered into the GMR. If the vehicle details in the GMR are different to the vehicle that arrives at the border location, you will not be able to board until the GMR is corrected.
