Change Description & Details	
Problem statement	A new ENS filing type (F59) has to be defined to enable the multiple ENS filings submission mechanism for the consignments transported via road. F59 allows the house filers to provide the goods shipment (buyer/seller) information only. It has already been submitted for incorporation in UCC Annex B.

Proposed solution

Information exchanges

A new ENS Filling type F59 (IE3F59, IE3A59) is introduced. It is a subset of F50 containing only the house level information.

The following updates need to be included:

- 1. PET04 – Manage timer for completion of risk analysis

No timer is to be applied for ENS filings F14, F15, F16, F22, F23, F24, F25, F26, F32, F33, F43, F44, F57, F58 and F59. In the case of filings F23, F24, F25, F32 and F43 the timer is not applied due to the legal requirement to complete the risk analysis immediately. However, if the risk is identified or additional risk analysis needs to be carried out, the 'time-limit' for the completion of the risk analysis is suspended.

- 2. PET09 – Link related filings and check completeness

In case of

- the filings F14, F15, F16, F22, F23, F24, F26, F32, F33, F43, F44, F53, F54, F55, F57, F58, F59 will obtain the state 'Linked' if they have been linked to the related master level filing that has been also lodged or the state 'Pending linking' if the related master level filing is missing.

- the filings F14, F15, F16, F22, F23, F24, F26, F32, F33, F43, F44, F53, F54, F55, F57, F58, F59 will obtain the state 'Linked' if the related master level filing has been lodged or the state 'Pending linking' if the related master level filing is missing.

- 3. Annex 1 – ENS Filling types – “F55 –Rail mode of transport – Partial dataset – Necessary information required to be provided by consignee at the lowest level of transport contract” to be added.
